- Recommends for hire, evaluates, trains, disciplines, and provides clinical consultation to assigned staff.
- Coordinates after-hours on-call schedules, including providing shift coverage as needed.
- Provides crisis intervention consultation services to staff providing after-hours crisis services.
- Delivers needs/risk assessments in crisis situations due to emotional, behavioral or psychiatric difficulty.
- Provides and ensures the delivery of community-based crisis intervention, de-escalation and immediate crisisfocused treatment to youth and their families during identified emergent situation to resolve the presenting crisis and prevent/reduce the need for care in a more restrictive setting.
- Provides and ensures referral services to the least restrictive setting appropriate to customer need. Ensures proper referral and follow up for those whose need is found to be for services elsewhere.
- Ensures adequate liaison with other community services.
- Acts as intern program coordinator with local school personnel, including ensuring documentation is in place to facilitate placements, communicating opportunities within VBCMH, and resolving any concerns with placements.
- Coordinates between intern candidates and VBCMH intern supervisors to enhance services and quality of placement experience.
- Develops systems for agency-wide successful onboarding of intern in conjunction with intern supervisors.
