- Ability to work independently and as part of a team: including the ability to be punctual; manage time and crisis situations flexibly and effectively; and demonstrate good judgment.

- Develops, implements, documents, monitors and reviews treatment plans and progress related to goals and objectives, including customer and family stability and effectiveness of services.
- Provides crisis intervention, assessment, individual and group therapy and psychoeducation, case management, therapeutic intervention, risk assessment, and other services as needed.
- Links and advocates with other agencies to ensure customers receive needed health and human services.
- Provides consultation with school staff, administration, parents, and other agencies to facilitate positive adjustment of customers (children) in school, home and the community.
- Acts as a resource to youth, families, school personnel, and agency staff.
- Ensures that services and documentation are in compliance with appropriate guidelines and standards.
- Intervenes with individuals, families or groups in coordination with the service/treatment plan to enhance or restore the capacity for emotional/social functioning in the home/school/community.
- Maintains adequate records, files, and documentation of services including those required for compliance with all state and federal regulations and/or grant requirements.
