Basic Responsibilities:

Provide effective and efficient assessments, testing, behavior analysis, counseling, and psychotherapeutic services to assigned adults and children with developmental disabilities and challenging behavior. Write, in-service and monitor Behavior Treatment Plans (BTP). Provide training to the community and/or inter/intra-agency entities. Serve as a resource to staff and the community on Positive Behavior Supports/Interventions and issues regarding developmental disabilities and mental illness.

Summary of Required Qualifications:

- Master's Degree in Psychology, Social Work, Applied Behavior Analysis, or related field with appropriate Michigan licensure or certification.
- Ability to effectively and efficiently utilize electronic EMR and telehealth mediums.
- A valid Michigan driver's license with an acceptable driving record.
- Ability to work independently and as part of a team, including the ability to be punctual, manage time and crisis situations flexibly and effectively, and demonstrate good judgment.
- One year of experience (including a supervised internship in therapy or counseling) working with persons with developmental disabilities or mental illness and developing behavior treatment plans and positive support strategies preferred.
- Experience in providing assessment/testing services and/or developing effective behavior treatment plans preferred.

Summary of Essential Job Functions:

- Conduct assessment and analysis of challenging behaviors displayed by assigned customers.
- Write and present BTP to the Behavior Treatment Review Committee (BTRC).
- Train staff, direct care providers and/or family members how to implement the behavioral program including all techniques incorporated and process for data collection.
- Provide regular follow-up and monitor behavior programs related to plan goals, objectives, and planned interventions, adjust as necessary for successful results, and complete periodic reviews, required assessments and status reports.
- Administer psychological testing, functional assessments and/or other evaluative instruments, and prepare interpretative reports, including making diagnoses using approved diagnostic nomenclature as assigned.
- Provide counseling and psychotherapeutic services to customers as appropriate and assigned.
- Participate as an interdisciplinary team member for triage with other staff in the review of services.
- Consult with psychiatrists and/or psychiatric nurses and attend medication reviews as needed.
- Act as liaison, in partnership with the Case Manager and hospital liaison, for assigned customers hospitalized due to challenging behaviors to coordinate services and ensure that all needs are being met.
