- Conducts and accurately documents initial/annual nursing care assessments on each member.
- Assesses clinical signs/symptoms of ACT members, their medications & needs and discusses with psychiatrist.
- Educates all ACT members, families, significant others, and staff about mental illness including information on target symptoms, cycles, precipitating stressors, medications and, potential side effects specific to program needs.
- Participates in all screening referrals and coordinates therapeutic interventions with members/families.
- Coordinates and advocates for ACT members' health care needs with other agencies/providers as needed.
- Provides nursing consultation to staff regarding members' health care needs.
- Provides 24 hour on-call coverage on a rotating basis and intervenes in crisis situations for members.
- Reviews, monitors, administers, and documents medications, and medication-related activities.
- Acts as a liaison with other agencies to ensure members' needs for independent living and purposeful activity are met.
- Follows through in the treatment of ACT members while they are in treatment centers, temporary housing, crisis homes, or hospitals as needed.
- Submits medication orders as directed by Medical Director/psychiatrist, documents, picks up medication orders, sets up medication boxes, and enters medication information/injections/labs into EMR.
- Facilitates and/or coordinates groups and provides mental and physical health education as needed.
