- Participates in all screening referrals for ACT/IDDT customers and coordinates therapeutic interventions; including
 person-centered and recovery-oriented care, stage-wise interventions, and motivational interviewing techniques,
 with individual customers and their families as needed.
- Links and coordinates with community agencies to assist customers in obtaining benefits & housing resources.
- Coordinates and leads ACT/IDDT treatment groups, focusing on Evidence-Based Practices and/or SUD.
- Evaluates needs for leisure time skills, community support, and health care specific to individual plan of service.
- Provides 24-hour, on-call coverage on a rotating basis.
- Intervenes in crisis as appropriate.
- Acts as a liaison with other community agencies to ensure customers' needs for independent living and purposeful
 activity are met according to all individual treatment plans.
